### 6. Business/Employment/definition of Town Centre – James

- Business Theme NHP arranged meeting held at Royal Chase on 10<sup>th</sup> July by Chamber of Commerce was well publicised and well attended.
- 12<sup>th</sup> August to be an arranged coffee morning/drop in meeting – which will be a 2<sup>nd</sup> opportunity for people to add comments
- 3 lists to be produced:- projects, objectives, rejected ideas.
- All events are being used as base evidence – examples being – most members of Chamber of Commerce would like to keep the town centre as ‘car friendly’; due to the lack of signage for Shaftesbury from major roads is an issue for the Chamber of Commerce and would worry that the Bypass would mean potential loss of trade – as the town may be missed by motorists due to poor signage; unified signage frequently gets raise as the current signs are dirty and damaged – also need to start linking the parking signs; parking a big issue for Chamber of Commerce as limits number of people coming

to shop; also, want to start looking into caravan parking – 3 neighbouring towns have introduced this; there needs to be an overall proposal to look into parking. Look into Shopping on a Sunday – with free car parking – have more shops open.

- A30 land for employment – need to make the land more marketable; use allocated land for employment; better use of cattlemarket – strategic section for Shaftesbury (Karen posted ideas as per Bakewell: <http://www.bagshaws.com/market-bakewell-market.asp>)
- Allocate space for Job Centre – need a ‘one stop shop’ for benefits; need to look into mixing small business in amongst residential houses.

### 7. Community Facilities Leisure – Community/leisure/culture - Lead Phil Proctor/support D Shepherd; Phil Beavis

- **Action: Richard to pass over all initial ideas document by Pierre to All.** There are currently 13 community halls in Shaftesbury with no support for a hub. There is currently no location to hold a business fayre in Shaftesbury; 11 small halls – need to analysis all 13 halls, maybe able to amalgamate two halls to create one larger one; St Peters maybe consider selling as residential; Christian centre.
- NDDC plans to identify the location of where the places are

### 8. Housing – NPH Theme has now been Assigned to S Rutter/P Proctor

- Brainstorming workshop to be organised

### 9. Open Spaces/Allotments/Cemeteries – Green Infrastructure for the whole town - Leads John/Bernie

- Public Health is key to planning; historically Shaftesbury used to be known as a ‘spa town’ so there is an historical link to health
- There are huge areas – circular land areas ideal for circular walks around Shaftesbury – need to look into if any Olympic funds/Taskforce.
